# Call To Action: Foreign Sulfide Mining in Minnesota by former Gov. Arne Carlson

Regardless of our station in life, we all share in the need for clean air, healthy water, and nutritious food. Today, our water and, ultimately, our food supply are all in very serious jeopardy. Just two mining projects, Tamarack and the New Range Copper

Nickel mines will place the bulk of Minnesota's drinking water at risk and this includes the metro area (Minneapolis and St. Paul).

For instance, the proposed Tamarack Mine operation will affect a number of waters including Big Sandy Lake and a variety of rivers including the Mississippi which services the Twin Cities and an endless number of communities heading south on the river. And the copper mine adjacent to the BWCA directly affects the Rainy River Watershed which encompasses the BWCA and extends from the western part of Lake Superior to Kenora, Ontario through Lake of the Woods.

Aside from all the marvelous hunting, fishing, camping, hiking opportunities that will be at serious risk, we stand to lose Lake Superior which is the world's largest body of fresh surface water and the ultimate reservoir for the upper Midwest.

Now let's quickly review the safety of sulfide mining. Woops! That's an oxymoron. After all, one of the consultants to the DNR referred to the holding bin for the New Range Copper Nickel Mine as a "Hail Mary" and another declared it made him "nauseous". Now that is a ringing endorsement for the protection of our most precious resource.

Sulfide mining has never been environmentally sound near a watery environment or "never - never "as expressed by Walter Mondale. From the best of my non scientific understanding, copper - nickel mining causes the release of sulfuric acid which then releases from the rocks certain acids, toxins, and contaminants into the water and air. Suffice it to say that the results are not healthy for any form of life.

Now, Glencore is making a serious bid to buy Teck Resources in an effort to be the number 1 copper producer in the world. This tells me that they are very, very confident of obtaining the necessary permits. That should frighten everyone because it would mean we are turning over our very lives to a foreign criminal enterprise. Just read below the findings by our own Department of Justice. #### Take It From Me, Minnesota: Steer Clear of Glencore

"I've been learning a lot about the PolyMet proposal to open a copper/sulfide mine in the state of Minnesota since moving here in 2019. What has shocked me is the lack of attention paid to PolyMet's owner, Glencore. As a native Cameroonian, I have a lot of experience with this company, and take it from me: It's not an experience we want in Minnesota...

Just this month, Glencore paid a \$180 million fine for corruption in the Congo. Last month we learned that 11 former Glencore employees could be under investigation in the UK for bribery in five African countries. Founder Mark Rich admitted to the bribery, including in my native Cameroon, in a case where prosecutors described the flying of cash bribes across the continent in private jets...

Google "Glencore fraud" for an interesting afternoon of reading. The United Steelworkers had it right when they named Glencore the second worst company in the world in 2015...

...People around the world are asking me the same question as they learn of the Glencore/PolyMet proposal, including NJ Ayuk, chair of the African Energy Chambers; and Akere Muna, one of the founding presidents of Transparency International."
