# **Prove It First Legislation**

Tamarack Water Alliance volunteers have been meeting with other local community residents who share our concern about the proposed Rio Tinto - Talon mine. Time and again, we hear people saying, "If they are going to do something risky, like mining for

metals in a wet area, then they ought to make sure they can do it right."

The proposed "Prove It First Law" is about exactly this. It is a common sense protection that says, "Before risky sulfide mining moves forward in Minnesota, there should be at least one example in the United States where it has been done safely."

This protection makes a lot of sense for Aitkin County residents. Our beloved lakes, rivers, peatlands and drinking water are put at risk by the Tamarack or Talon Metals nickel mine that is close to initiating a permitting process with state regulators.

Global mining giant Rio Tinto–Kennecott controls the mineral leases that Talon Metals is currently exploring and marketing to investors. Rio Tinto–Kennecott have a documented track record of environmental degradation and human rights abuses all around the **globe**. On March 6, Rio Tinto agreed to pay \$15 million USD to settle a seven-year bribery scandal regarding the undeveloped Simandou iron ore deposit in Guinea, one of the most valuable in the world.

Because of the company's history, we must be very careful. Global mining companies spend millions on lobbyists and marketing, all in an effort to downplay the dangers of their projects, especially to local communities.

These corporate buyouts happen here in Aitkin County, as well as in Washington, and as a result, federal investment in industrial development has now preceded any local or regional studies or reviews of mine safety.

Before any official permitting, scientific studies, or consultations with Native nations have even begun about the controversial Rio Tinto-Talon mine, the Biden-Harris Administration announced \$114 million in federal subsidies to Talon Metals for a "battery materials processing" plant located in North Dakota – which would process material mined in Tamarack and transported by rail.

This facility has also not undergone any permitting or scientific review, but according to Talon Metals, it would streamline the permitting process in Minnesota in Talon's favor.

This is not a Democrat or Republican issue, it is about being fair and responsible neighbors, and applying rigorous standards to new development projects. Most Minnesotans support protections which require independent scientific proof that a coppernickel mine has operated safely in the US for at least 10 years without causing pollution and that the mine has closed for 10 years without causing pollution before allowing such a mine in Minnesota. https://www.mncenter.org/2021\_poll

**Tamarack Water Alliance** (tamarackwateralliance.org) is a group of local residents and landowners working together with others from across Minnesota to protect water and community health from the dangers of sulfide mining near our beloved lakes and wild rice beds, at the headwaters of the Kettle River and in the Mississippi River watershed.

A proposal by a foreign owned mining company to mine nickel and other metals near Tamarack in Aitkin County threatens the health of our communities. This kind of sulfide mining, especially in water-rich environments, has never been done without severe impacts to water and the health of those downstream. Mining here is also a threat to

environmental justice and the long-term economic security of nearby native and rural communities.
